ARTICLE I  
NAME, MEMBERSHIP AND BOUNDARIES

The name shall be the WARD 3 NEIGHBORS ALLIANCE, INC. It shall offer membership to all residents, property owners, and business owners having interests within the Ward 3 boundaries (as described in the City of Tucson definition for each Ward).

ARTICLE II  
PURPOSES

- A. To establish a cooperative alliance among neighbors and neighborhood associations for the achievement of common goals.
- B. To provide a vehicle for communication among and between neighbors on topics of concern within Ward 3.
- C. To provide information and organize activities on topics related to healthy neighborhoods.
- D. To serve as a fiduciary agent for the Alliance members, providing the advantages of a 501c3 non-profit corporation for beneficial purposes.

ARTICLE III
